Dáil Question No: 146:

To ask the Minister for Transport if he has conducted a capacity review of his Department's ability to deliver services that they are responsible for in the past ten years to date; the same of State bodies and agencies under his Department's aegis; if he published those reviews; the number of recommendations implemented arising from the reviews and same for State bodies and agencies under his aegis; if the capacity review was outsourced; and if so, to whom and at what cost.

Dear Deputy Murphy,

The National Aviation Policy published in 2015, included a commitment to an independent review of the capacity needs of Ireland's State airports and the potential for a third terminal at Dublin Airport. This review was conducted by Oxford Economics and Cambridge Economic Policy Associates (CEPA) and was published by the Minister for Transport, Tourism and Sport, Mr. Shane Ross, TD, on 26 October 2018. This paper was published by the Department at: <u>gov.ie - Independent Review of Capacity Needs of Ireland's State Airports</u>

This review recommended the prioritisation of Terminal 1 and Terminal 2 expansions, as the timeline for a third terminal at Dublin Airport would fail to relieve short-term capacity constraints. Since 2018, daa has delivered numerous projects aimed at increasing the capacity at both Dublin and Cork Airports. A list of the significant investments made by daa is set out below as of September 2024.
